Why teach Climate Change and Green Living?

Teaching young people about climate change can help them understand the severity of the current environmental situation and the importance of taking active steps to do their part in preserving the planet.

Education can encourage people to change their attitudes and behaviour; it also helps them to make informed decisions. In the classroom, young people can be taught the impact of global warming and how to adapt to climate change. Education empowers all people but especially motivates the young to take action. Knowing the facts helps eliminate the fear of an issue frequently coloured by doom and gloom in the public arena.

The world is home to 1.8 billion young people between the ages of 10 and 24 — the largest generation of youth in history. Young people are increasingly aware of the challenges and risks presented by the climate crisis and the opportunity to achieve sustainable development brought by a solution to climate change.
